All members of the Board were present, thus constituting a quorum.

Also present were Mr. Jim Sheffield, the District's General Manager; Ms. Cherrelle Burkhalter, an employee of the District.

WHEREUPON, following a notation that notices of the meeting had been duly posted in accordance with law, copies of which are attached hereto as exhibits, the meeting was called to order.

#### TOUR OF NORTHCREST FACILITY

The Board toured the following areas and assessed the facility. The following recommendations were made:

#### General Park Area

- Park Sign "closes at dark" needs to be straightened
- Marquee Sign Paul will order new sign
- Trees should be trimmed 10' to 12' up
- Prune fruit trees and other trees November through February
- Pampas plant located next to cypress tree needs trimming
- Apply ant killer
- Cover to water valve needs to be replaced
- Remove vines and cut limbs at the entrance to park (across from MUD Building)

- Magnolia tree not surviving -find seasonal trees to replace the Magnolia tree
- Trails build low areas or replace areas with asphalt
- Discussed whether to put borders around trails
- Need to address the water areas behind the creek where the tennis courts are going
- Creek waterfall blow off pine needles from rocks
- Inform employees to park in parking areas and no on grass
- Have graffiti removed from pump house
- Two trees removed
- Tallow tree located between pond and EZ4U
- Along fence (Cherrelle has a picture)
- Remove weeds and yaupon around bench seating
- Remove poison ivy and dead juniper around pine tree located next to pond pavilion
- Flowerbed next to walk over bridge
- Remove Virginia creeper and Wild mulberry tree

## Wooden fence and over grown area – located behind EZ4U

- Repair fence and broken pickets
- Remove dead tree limb
- Vines removed
- Leave shrubs and roses
- Pick up trash
- Trim trees along fence
- Kill weeds on both sides of the fence (not on a windy day)

#### Pond Pavilion

- Replace missing cover plate
- Lights glass shields missing or not attached
- Remove nut grass around pavilion

## Tennis Area

- Storage building needs coat of paint
- Red cement flooring is chipped and needs repainting
- Cover PVC piping located outside of storage area
- Top of fence is out of its bracket in two locations
- Light pole repair nut bolt and have all bolts and nuts checked

#### Northcrest Wooden Pavilion

- Light cover shields missing or falling off
- Electrical cover missing on outlet

## Pool Deck

• Expansion joints are needed (repair by means necessary)

### **NCAB**

- Front and pool side windows solar film
- Remove tape from windows
- Wall border needs to be repaired

## Playground Park Area

- Next to bath house remove juniper and trees
- Remove small brush under trees
- Remove small tree located between NCAB and the playground

## Metal Northcrest Pavilion

- Remove weeds from flowerbeds
- Water sprinkler head broken

## Constable Substation

- Discussion on what to do with the space
- Need new toilet and sink
- Vinyl flooring
- Ceiling need replacing
- Light bulbs and covers replaced
- Per Jim Sheffield, it would cost around \$6,000.00 to get the front room and bathroom ready for use.
- Have front flowerbed area cleaned. Director Schneider will bring ferns to plant

There being no further business to come before the Board, the meeting was adjourned.
