I, the undersigned Secretary of the Board of Directors (the "Board") of Northampton Municipal Utility District (the "District"), hereby certify as follows:

ORDER SETTING 2018 TAX RATE

WHEREAS, the District has issued and sold certain bonds which are currently outstanding;

WHEREAS, the District must levy a tax on all taxable property in the District to provide for payment of interest on and principal of its bonds as said bonds mature;

WHEREAS, a portion of the tax rolls for the year of 2018 have been finally approved by the Appraisal Review Board;

WHEREAS, the District has calculated the tax rate necessary to provide for the payment of principal and interest on the District's outstanding bonds as such bonds mature, and further, to provide for the payment of certain operation and maintenance expenses of the District;

WHEREAS, the Financial Advisor for the District has made a recommendation as to what the tax rate should be;

WHEREAS, on November 6, 2012, an Election for Designation of a Defined Area, Authorization of Unlimited Tax Bonds for the Defined Area, and Maintenance Taxes for the Defined Area was held where a majority of qualified voters of the District voting at said election approved the designation of the "Defined Area," in accordance with the propositions submitted at said election;

WHEREAS, pursuant to said election, the Defined Area shall have a separate rate of taxation that is in addition to the rate of taxation set by the District that is applicable to all property within the District, including the Defined Area;

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF NORTHAMPTON MUNICIPAL UTILITY DISTRICT THAT:

I.

The District tax rate for the year 2018 shall be a total of \$0.58 per \$100 of assessed valuation, comprised of \$0.33 per \$100 assessed valuation for debt service purposes and \$0.25 per \$100 assessed valuation for operation/maintenance purposes. The District tax rate shall apply to all property within the District, including the Defined Area. The District's Tax Assessor and Collector shall take all steps necessary and authorized by law to collect taxes as owed pursuant to this Order. Said taxes shall be levied, assessed and collected at the rate of \$0.58 per \$100 of assessed valuation for 2018 as provided for in Chapter 49, Texas Water Code, and all other applicable laws.

II.

The Defined Area tax rate for the year 2018 shall be a total of \$0.64 per \$100 of assessed valuation, comprised of \$0.345 for debt service on Defined Area water, sewer and drainage bonds and \$0.295 for debt service on Defined Area road bonds. The Defined Area tax rate shall apply only to the property within the Defined Area, and shall be in addition to the District tax rate. The District's Tax Assessor and Collector shall take all steps necessary and authorized by law to collect taxes as owed pursuant to this Order. Said taxes shall be levied, assessed and collected at the rate of \$0.64 per \$100 of assessed valuation for 2018 as provided for in Chapter 49, Texas Water Code, and all other applicable laws.

III.

The District specifies that the revenues derived from the tax levy shall be recognized in the calendar year ending December 31, 2019.

IV.

The President or Vice President is authorized to do all things necessary for execution of this Order; and the President or Vice President is further authorized to execute, and the Secretary or any Assistant Secretary to attest, this Order on behalf of the Board of Directors.
